## **ALL RIGHTS RESERVED PUBLISHING AGREEMENT** *(INCLUDING GREEN OPEN ACCESS)*

The following is an agreement between the “Corresponding Author”:

**To expedite the editing and publishing process and enable Common Ground Research Networks to disseminate your Work, we need to have this Agreement executed. If the Work is not accepted for publication, or if the Work is subsequently rejected, this Agreement will be null and void. Publication cannot proceed without a signed copy of this Agreement and payment of the appropriate article publication charge in full.**

### **1. ASSIGNING OF COPYRIGHT**

The Corresponding Author transfers and assigns to the Publisher, during the full term of copyright and any extensions or renewals of that term, all copyright in and to the Work, including but not limited to the right to publish, republish, transmit, sell, distribute and otherwise use the Work in electronic and print editions of the Journal and in derivative works throughout the world, in all languages and in all media now known or later developed, and to license or permit others to do so.

### **2. AUTHORS RETAINED COPYRIGHT**

Notwithstanding the above, the Authors retain all proprietary rights other than copyright, such as patent rights, in any process, procedure or article of manufacture described in the Work. The Journal grants back to the Authors the following distinct rights:

- The non-exclusive right to use, reproduce, distribute, publicly perform, and publicly display the Work in any medium in connection with the Authors’ academic and professional activities, including but not limited to teaching, conference presentations, and lectures.

#### 4. AUTHOR'S DUTIES

When distributing or re-publishing the Work as authorized above, the Corresponding Author agrees to credit the Journal as the place of first publication. Without an Open Access agreement, the author(s) and co-author(s) may not post the Version of Record (VoR) of the work to commercial repositories or social media sites such as academia.edu or ResearchGate. They may post the title, the abstract, and a link to the Common Ground bookstore on these or any other websites

#### 5. AUTHOR'S WARRANTY
